II. Privacy Policy

This policy applies to information we collect on the website and in connection with the Services, including but not limited to the collection of payment information.

It does not apply to information collected by:

- AMTS offline or through any other means, including on any other website operated by AMTS or any third party; or
- Any third party, including through any application or content (including advertising) that may link to or be accessible from or on the website.
